

Performance Agreement

This agreement, entered into on 3/15/23. By and between Purchaser and Artist (as defined below) is for the employment of the personal entertainment services of Artist, on the engagement described below. PURCHASER and ARTIST, in consideration of the mutual convenience hereinafter set forth, agree as follows:

1. PURCHASER Alpine Artisans
2. ARTIST Rebecca Folsom 4-piece Band

3. ENGAGEMENT Community Show and Two Outreach Program
- Place of Engagement: Seeley-Swan High School
- Address: 450 Airport Road, Seeley Lake, MT 59868
- Date(s) of Engagement: October 6th-8th
- Hours of Engagement: 3 pm 2 45-minute sets
- Contract Fee Agreed Upon \$ 5,000.⁰⁰
- Deposit Due: \$ 500.⁰⁰

4. PURCHASER shall pay ARTIST fee or balance in cash, corporate or cashier's check immediately following engagement.
5. For outdoor engagement, PURCHASER shall provide ARTIST necessary electricity and a suitable stage. In case of rain, sleet, snow or inclement weather, PURCHASER shall provide an alternate warm, dry, indoor performance location. ARTIST is to be paid the full contract price regardless of stage location. Failure of PURCHASER to do so will be considered a cancellation of this agreement and ARTIST shall be paid according to agreed contract fee above.
